The dealer shall be liable for any and all damage to the space leased to the dealer, or any part of the premises owned by the Village and Town of Palmyra, Zion Episcopal Church, Western Presbyterian Church, Hasseltine Liquor, and the Union Agricultural Society at Palmyra.
